#### Introduction and purpose

The Rio Tinto Children's Diabetes Centre; A JDRF Global Centre of Excellence, ("the Centre") based at the Telethon Kids Institute and Perth Children's Hospital in Western Australia is an integrated clinical and research centre conducting research into childhood diabetes.

Our goal is to improve the lives of all young people living with diabetes, their families and community by bringing together research, education and clinical care. The Centre is supported by five national and global institutions/hospitals (Perth is the lead site). The Centre aims to encourage new and innovative research, researchers and translation ideas and projects.

The Centre has established Talent & Capacity Building Scholarships with the purpose of providing support for PhD students undertaking their research in type 1 diabetes related to the objectives of the Centre<sup>1</sup> to build capacity, encourage dissemination of research findings and facilitate exchange of skills. Successful applicants will receive up to AUD\$5,000 per annum for up to three years full-time. **Up to four Talent & Capacity Building scholarships will be available in Round2/2023**. Applicants will be assessed on the eligibility criteria and the information gathered from the application form.

Applications for the Talent & Capacity Building scholarships are to be emailed to <u>JDRF.GlobalCoE@telethonkids.org.au</u> no later than 4pm (AWST) on the Monday 16 October 2023.

#### **Eligibility Criteria**

- Must currently be undertaking their PhD in a type 1 diabetes-related field
- Applicants must be affiliated with or endorsed by a Centre Institution or researcher as listed in Attachment A.
- PhD project/s must demonstrate alignment with the objectives of the Centre.

- 2. To promote effective transfer of research outcomes into health policy and/or practice.
- 3. To develop novel advanced economic frameworks that include the broad true costs of T1D to enhance access to novel therapies and share policies.

Applications for the Talent & Capacity Building scholarship will be forfeited if:

- 1. Applicants are in their final 6 months of their PhD.
- 2. Applicants are recipients of a JDRF Australia Top-up scholarship.
- 3. The application is received after the closing date.

### **Obligations of the Administering Institution/recipient**

The recipient will receive up to AUD\$5,000pa for a maximum of three years full time.

- 1. The Talent & Capacity Building scholarship will be awarded for 1 year in the first instance and may be renewed annually (for a total award duration of three full-time years) subject to the recipient remaining enrolled in their PhD degree and implementing their proposed capacity building plans.
- 2. An annual progress report from the recipient needs to be submitted both 12 and 24 months of being awarded the Talent & Capacity Building scholarship; unless the end date of the award is prior to the 24-months reporting and in which case, the recipient would need to complete a final report as per terms #4 below. This report would require receipts of expenditure and supervisor sign off.
- 3. Request to roll over funds can be made at the time of the scholarship annual reporting.
- 4. A final report needs to be submitted within 3 months of the completion of the award period.
- 5. The Talent & Capacity Building scholarship can be used for (but not exclusive to): conference registration; travel and accommodation cost for conference attendance; journal fees for publications; and travel and accommodation cost for exchange experience to another Centre Collaborator's site.
- 6. The Centre needs to be notified of any changes to the recipient's PhD program, at which time the scholarship will be reviewed by the Talent and Capacity Building Subcommittee. These may include, but are not exclusive to:
  - a. Change in the recipient's PhD load,
  - b. Institution transfer,
  - c. Extended leave, such as maternity and paternity leave,
  - d. Change in their proposed capacity building plans
- 7. Recipient needs to acknowledge the financial support of JDRF in any publication/presentation arising from the work being supported through this scholarship. Acknowledgement should be in the form of:

This research was supported by JDRF Australia Talent & Capacity Building Scholarship (grant number 5-SRA-2021-1088-M-X).

- 8. Provide a copy of the publications concerned to the Centre for review by the Scientific Program Subcommittee at least two weeks (14 days) prior to submission.
- 9. The administering Institution agrees to wave all fees associated with the administration of the scholarship.

## How do I claim funding if my application has been approved?

1. Payments in respect to the scholarship shall be within the terms and conditions specified in the scholarship offer.

- 2. The administering Institution may invoice the Centre within 1 month of the recipient's Talent & Capacity Building scholarship award notification. Thereafter, the award will be paid in yearly instalments on receipt of a tax invoice from the Administering Institution and a progress report from the recipient.
- 3. Amounts granted are in Australian Dollars and are exclusive of GST for Australian applicants. All claims are to be made via a tax invoice from the Recipient's GST registered Administering Institution, including the institution's ABN. This is to avoid paying withholding tax which would reduce the overall grant by 48.5%. Please keep in mind that the invoice must include GST on top of the total grant (i.e. the invoice must include 10% extra for the GST).
- 4. In exceptional/extenuating circumstances, and upon formal application, the Centre Co-Directors, at their discretion, may approve a variation to the payment method outlined above.
- 5. An awardee is required to repay any scholarship overpayment within thirty calendar days of being requested to do so.
- 6. It is the responsibility of the recipient to assess the tax liability of their Talent & Capacity Building scholarship. The Centre cannot provide advice regarding taxation. Please refer to the taxation rules for your country.
